



## PETRONAS SHOP “MOVE INTO BETTER YOU” TERMS AND CONDITIONS

### 1.0 Organiser:

- 1.1 PETRONAS Shop, which is the [retailer of PETRONAS branded merchandise] under Setel Express Sdn Bhd, is the organiser of this **“MOVE INTO BETTER YOU”** (“Campaign”).
- 1.2 The following terms and conditions apply in respect of this Campaign. By participating in this Campaign, you agree to be bound by these terms and conditions, including any term which may have been amended from time to time, without limitation or qualification.

### 2.0 Eligibility:

- 2.1 This Campaign is open to customers who fulfil ALL the below requirements:
  - (a) Registered PETRONAS Shop members at <https://www.setel.com/PETRONAS-Shop>; or Setel Mobile Application (“Setel App”) and
  - (b) Customers holding Malaysian citizenship; and
  - (c) Customers aged eighteen (18) and above.

Customers who fulfil all the aforementioned requirements shall be hereinafter referred to as “Participant” or “Participants”.

- 2.2 The following persons are NOT ELIGIBLE to participate in the Campaign:
  - (a) Permanent/Contract employees of Setel Express Sdn Bhd and their immediate family members, specifically their respective fathers, mothers, spouses and children;
  - (b) Employees of event platform agency for Setel Express Sdn Bhd and their immediate family members, specifically their respective fathers, mothers, spouses, and children; and
  - (c) partners/business alliances/sponsors and their employees.

2.3 In the event a Participant is found to be ineligible at any point of time during or after the Campaign Period as stated below, PETRONAS Shop reserves the right, at its sole discretion, to disqualify the said Participant and to cancel/withdraw/recall any prize won by the Participant. If the said Participant has used or enjoyed the prize, the Participant agrees and undertakes to indemnify PETRONAS Shop for the costs of such prize and PETRONAS Shop shall have the right to initiate any action it deems necessary against the said Participant.

### 4.0 Campaign Period:

4.1 Unless otherwise notified by Petronas Shop, the Campaign will be conducted from **1st April 2026 - 30th April 2026** ("Campaign Period"), both dates inclusive.

4.2 Customers who spend a minimum of RM150 in a single transaction are eligible to participate in the contest and stand a chance to win selected wellness-related prizes, subject to terms and conditions.

**5.0 Campaign Mechanics:**

- 5.1 Participants must spend a minimum of RM150 in a single transaction on the PETRONAS Shop website (<https://www.setel.com/PETRONAS-Shop>) during the Campaign Period to be eligible.:
- 5.2 For the avoidance of doubt, the purchase of vouchers, including but not limited to Setel vouchers or any other gift or promotional vouchers, is strictly excluded and shall be not counted towards the minimum spend requirement.

- 6.3 The prize shall be dispatched via mail, and notification and fulfillment endeavors will be completed within a specified timeframe of 30-45 working days. The winner will be notified through the mobile number provided in the delivery details. The prize shall be dispatched via mail, with notification and fulfillment targeted within 30-45 working days. Contact with the winner will be established using the mobile number provided in the delivery details. The winners will be required to fill in a declaration form. In the event of delay with regard to the fulfilment of prizes(s), PETRONAS Shop will communicate this to the winners.
