



## **Carro x Setel RM300 Cashback for Selling Cars Campaign Terms & Conditions**

### **1.0 Organiser:**

Setel Ventures Sdn. Bhd. ("Organiser") is the organiser of the "Carro x Setel RM300 Cashback for Selling Cars Campaign" ("Campaign"). Carro is a trademark registered under mytukar Sdn Bhd, also known as "Carro Malaysia".

### **2.0 Campaign Period:**

Unless otherwise notified by the Organiser, the Campaign will be conducted from 1 May 2024, 12:00 am (GMT+8) to 31 May 2024, 11:59 pm (GMT+8) ("Campaign Period"), both dates inclusive.

### **3.0 Eligibility:**

This Campaign is open to all Setel Application ("App") users who book a car inspection session via the Setel x Carro promo page for selling cars ("Participant(s)").

### **4.0 Campaign Mechanic:**

4.1 To participate in this Campaign, Participant(s) are required to open a Setel account and complete the registration process. Participant(s) must ensure that the phone number and name registered in the proof of selling the car match the information provided in the Setel App.

4.2. To be eligible for this Campaign, Participant(s) are required to complete the booking of a free inspection and sell off the used car during the Campaign Period through the Setel x Carro promo page for selling cars to receive RM300 Setel cashback.

4.3 There are no Mesra points that will be given to the Participant(s) for every sold used car through the Setel x Carro promo page. Mesra Rewards points are only eligible for purchases made with Setel at physical stores or online stores, for parking, road tax, auto assistance, motor insurance, EV charging, and Deliver2Me (except Mesra ('Selected Features')).

4.4 The RM300 Setel cashback amount will be credited automatically into the respective Participant(s) Setel Wallet within THIRTY (30) business days once the sale is deemed successful from Carro.

4.5 Each vehicle sold through the Campaign page is entitled to ONE (1) RM300 Setel cashback, provided the Participant(s) has successfully booked an inspection and sold



used cars through the Setel x Carro promo page for selling cars.

4.6 For the avoidance of doubt, a sale shall be deemed as successful once a Participant(s) has sold a car to Carro and completed the transfer of ownership of the car to Carro.

4.7 This Campaign will not be valid if the Participant(s) booked a car inspection and sold used cars through Carro's web, app, or other platforms that are not through the Setel x Carro promo page for selling cars.

4.8 The Campaign reward is non-exchangeable for other gifts, vouchers, cash, or credit under any circumstances.

4.9 Setel cashback can be used to pay for fuel, motor insurance, parking, and items in Kedai Mesra, Deliver2Me, and at the online and physical retail stores that accept Setel Pay.

#### **5.0 Miscellaneous:**

5.1 The Organiser reserves the right to make further verifications and requests for additional personal identification details and documents from the Participant(s), as well as the right to disqualify or withdraw the Participant's eligibility for the reward at any time, should there be any non-compliance to these Terms and Conditions.

5.2 By entering or participating in the Campaign, Participant(s) hereby fully and unconditionally agree and accept all the Terms and Conditions herein contained and agree that the decisions of the Organiser regarding the Campaign and all matters relating to or in connection thereto are final and binding and no such queries, appeals or correspondences will be entertained.

5.3 In the event of a disqualification occurring after the Setel cashback has been redeemed by the defaulting Participant(s), Setel reserves the right to demand the return of the Setel cashback or payment of its equivalent value from the Participant(s).

5.4 The Organiser reserves the right to cancel, shorten, extend, suspend, or terminate the Campaign at any time before the expiry of the Campaign Period without prior notice to the Participant(s).
