

**“SERVIS IHSAN MADANI @ PETRONAS
AUTOEXPERT”
TERMS AND CONDITIONS**

1.0 Organizer:

- 1.1** PETRONAS Lubricants Marketing (Malaysia) Sdn Bhd (“**PLMMSB**”) is the organizer of this “Servis Ihsan Madani @ PETRONAS AutoExpert” (“**Program**”) in collaboration with Kementerian Perdagangan Dalam Negeri dan Sara Hidup (“**KPDN**”).
- 1.2** The following terms and conditions apply in respect of this Program. By participating in this Program, you agree to be bound by these terms and conditions, including any term which may be amended from time to time, without limitation or qualification (“**Terms and Conditions**”).

2.0 Eligibility:

- 2.1** The Program is open to all Malaysians including:
